Article 8: Bereavement Leave

In the case of the death of a member's spouse/domestic partner, child, parent, grandparent, or (whether adopted, natural, step, foster, or in-law), the member shall be granted a leave of absence without loss of pay for a period not exceeding (4) consecutive working days beginning with the death, and that no day during this period on which the member has been on duty shall be counted computing the length of leave.


